After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a Sweepstakes allowed, 2 lbs.; two races other than maiden or claiming 4 lbs.; a race other than maiden or claiming 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters. Preference to start will be given to Stakes winners, then those horses that have accumulated the highest career earnings. Failure to draw into the race cancels all fees.
