After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 121 lbs. Non-winners of a Sweepstakes at a mile or over since October 1 allowed, 2 lbs.; \$19,500 twice at a mile or over since August 1, 4 lbs.; of two races other than claiming at a mile or over in 2008-2009, 6 lbs.
