After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 121 lbs. Non-winners of a Sweepstakes at a mile or over since October 1, allowed 2 lbs; \$25,000 twice at a mile or over in 2008-2009, 4 lbs.; \$21,000 at a mile or over since September 3, 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters. Preference to start will be given in the following order: Graded/Group Stakes winners (in order I-II-III). Stakes winners, then highest total earnings in 2008-2009. Failure to draw into the race cancels all fees.
